A LETTER FROM THE EXECUTIVE DIRECTOR

Dear JAC Supporters & Friends,

Writing this letter and trying to highlight and discuss all we have been through in 2019, 2020 and 2021 is quite a task and in some ways, I am not sure where to start. We have had great successes, seen great growth and change, and also learned so much while we navigated a pandemic along with all of our partners and communities. There were happy times, sad times, and scary times, but most importantly, these times forced us to come together as a staff and Board and to focus in on helping youth & families through these challenging times.

2019 proved to be a busy and significant year for the Juvenile Assessment Center (JAC)! We saw the successful transition of our Law Enforcement Program into two new locations, within the Family Resource Pavilion and Marvin W. Foote Youth Services Center. Being able to serve our non-detention eligible youth in a community setting rather than in a jail setting far surpassed our expectations! We also saw more growth within Community Assessment Program and added two new Clinicians to the team in order to better serve youth in a preventative manner. We also saw the resignation and departure of our much-loved Executive Director, Molli Barker. She had been with us for 3 years and had such an amazing impact on the JAC during that time. Unfortunately, when we lost Molli, we also lost our favorite, furry staff member, Meatloaf. He was the resident therapy dog, but he belonged to Molli and she was pretty insistent he had to move with her despite staff protests

I took over as our Executive Director on January 1, 2020 and had no idea what would be in store for me or for the agency just a few months later. Along with the rest of the world, we shut our doors to all in-person work in the middle of March and had to adjust to screening and assessing over the phone and through tele-health platforms, as well to the new normal of virtual meetings. The resilience and adjustment of staff was amazing to watch and I could not have been more proud of the team and their commitment to our agency, their fellow staff, and to the youth & families we continued to serve. We resumed in person operations on June 1st, which came with new challenges and adjustments (mask wearing and social distancing!), but we weathered through in order to be together and in-person. We also opened our doors to another community location in Aurora that August, but unfortunately we were also experiencing a decline in law enforcement transports due to COVID and therefore were unable to remain in that location as we had hoped and planned for. The decline in transports we were experiencing was not unique to our JAC or our community and instead of focusing on the change and wondering when we would get back to normal, we decided to start brainstorming with our law enforcement partners on new ways to work with the youth they were encountering and instead saw an increase in prevention referrals to our Community Assessment Program. One of the best things to happen in 2021 was the formation and launch of the National Assessment Center Association (NAC)! Our former Executive Director, Molli Barker, was the genius behind starting the NAC and what a welcome addition a national association would be for assessment centers across the country! In trying times, the AC became a place of support and networking for all of us. We are proud to be partners of the NAC and look forward to this partnership for years to come! The decline in law enforcement transports through our Law Enforcement Program and the increase in school and community referrals to our Community Assessment Program continued throughout 2021. While this is not what we expected, we again chose to view this as our new normal and adjusted to the change by focusing on our partnerships and new possible ways of doing business. Things felt as normal as they possibly could in 2021 and we are excited to say we were able to remain open to in-person work the entire year!

As we continue to grow and serve more youth and families, we as a staff are dedicated to continuing serving with the highest standards. We strive to continue creating a safe space for all families so that they feel heard and know we will do whatever we can to assist them. Thank you to everyone for your continued support of the JAC and here is to a fantastic year in 2022!
